



OVERALL LANDSCAPE PLAN



Schedule A Protection Barrier Distance from Tree Section 1.2




General Construction Notes:

Any permitted tree removal(s) must be performed by qualified professional to avoid contravention of Work Safe BC regulations.

No grade changes are to occur within the Critical Root Zones of any retained trees.

Construction materials are not to be stored within the Tree Protection Zones (TPZ) of trees to be retained, and TPZ fencing is to remain intact for the entire construction process. Signage must be clearly posted on each side of the barrier indicating 'TREE PROTECTION ZONE – DO NOT ENTER OR MODIFY'. Consult Arborist (Mountain Maple) for any TPZ barrier issues.

The barrier shall clearly display all-weather signage indicating that the area is a protected zone. Any work which must be done within the protection zone is to be done by hand. No burning is to take place close enough for the flames or heat to damage any tree to be retained.
