- a) STAFF
  - i. <u>101 149 Lonsdale Avenue</u> The building currently housing the Moodyville Café has been protected through a covenant. Legal Heritage protection will be presented for Council's consideration in June. The Bylaw is a stronger form of protection.
  - ii. <u>117 135 West 1<sup>st</sup> Street</u> The Public Hearing is closed. Legal agreements are being prepared with Fairborne. The application will be brought forth for final adoption.
  - iii. 275 West 6<sup>th</sup> Street 2 unit duplex Staff are currently reviewing the application.
  - iv. <u>1337 Jones Avenue</u> This B ranked building, may be included as part of a development application. We expect Donald Luxton & Associates to work on the project.
  - v. <u>320 Tempe</u> The applicant did not designate the home during the rezoning process. Work has finally started on this property.

## a) Introduction & Role of the Commission

## c) Heritage Program Overview

C. Wilkinson presented a PowerPoint Presentation. He advised that, with several new members, this is a good opportunity to rehabilitate the heritage program.

#### Highlights included:

- Heritage is defined as non-moveable objects such as land & buildings, landscapes and structures.
- Part 27 of the Local Government Act is what allows municipalities to have a heritage program.
- Ways to rehabilitate our heritage program include public awareness, regulatory controls, heritage incentives and zoning bylaw amendments which could be used as incentives.
- Heritage incentives include a density bonus for heritage retention. For low density, permitted accessory uses could be expanded, grants/property tax exemptions could also be provided – subject to analysis and Council approval.
- On HAC's work plan is an outstanding Council resolution to explore incentives for heritage home owners.

#### **HAC Questions/Comments:**

- Are there heritage incentives in the new OCP?
  - Density bonusing remains part of the new draft OCP. However, the OCP is the highest level document and consequently more general. The next level of policy development would get into details and incentives. This is why it could be important to revitalize our program.
