The meeting was called to order at 6:00 p.m. by the Chair.

It was decided by acclimation to move item #1 to item #3.

#### 1. NEW BUSINESS

#### a) Presentation of Heritage Plaques

C. Wilkinson gave a short PowerPoint presentation on CNV's Heritage Plaque program and a bit of background on each home.

### 278 West 5<sup>th</sup> Street – Grant Residence

Built in 1923, this house was rezoned in 1994 to permit an infill in the rear yard of the lot. As a condition of rezoning the Grant Residence was legally protected. Owners Tami Chappell and Harrison Cookenboo were presented with the plaque.

# • <u>246 East 10<sup>th</sup> Street – Crease Residence</u>

Built in 1911, this house is in the East 10<sup>th</sup> Street Heritage Character Area. It was legally designated as a Municipal Heritage Site in 1992. Owners Luke Pretty & Todd Pretty were presented with the plaque.

# • 146 East 3<sup>rd</sup> Street - Wright Residence

Built in the early 1900's, this house was designated in 1996 as part of a development application that included a new infill building at the rear. The

Chair, L. Grierson, presented the plaques to the owners in attendance and photos were taken with the Commission.

#### 3. GUEST SPEAKER

Peter Miller, North Shore Heritage Preservation Society

Peter Miller from the North Shore Heritage Preservation Society (NSHPS) gave a presentation.

#### Key Points:

- The North Shore Heritage Preservation Society was established in May 2005, incorporated as a society in June 2005, and registered as a charity in July 2007.
- Their mandate is to educate and raise awareness about the merits of heritage buildings and culturally significant natural features.
- NSHPS was originally two groups which amalgamated; the North Shore Heritage Network and the Hodgson House Society.
- Their 3 main activities are raising awareness, advocacy and education.
- Raising awareness includes displays at public events, speaking at elementary schools and workshops on windows, true colours, etc.
- In their role as advocate, they have helped save several heritage buildings on the North Shore including the Commercial Block at St. Andrews and 8<sup>th</sup> and Ridgeway School.

#### Questions/Comments from HAC:

• The level of connection with the community on the Society's List Serve is excellent. It is a great place for heritage related dialogue and questions among the community.

#### 3. ADOPTION OF MINUTES

The minutes of October 14, 2014 were adopted as circulated.

D. Gosse requested that an update on the paint colour of 252 East 10<sup>th</sup> Street be added to Staff Updates.

#### 4. UPDATES

- a) STAFF
  - i. 275 West 6<sup>th</sup> Street Has been approved by Council and received final adoption.
  - ii. 214 West 6<sup>th</sup> Street May be reconsidered by the Advisory Design Panel in December. Staff toured the home yesterday and are working with the applicants on a Conservation Plan.
  - iii. 2<sup>nd</sup> Shipyard Crane Staff are looking into legal agreement.
  - iv. 252 East 10<sup>th</sup> Street Staff will not pursue the repainting of the home back to its previous colour scheme. The Heritage Designation Bylaw states that a Heritage Alteration Permit is not required for a heritage homeowner to re-paint their home's exterior. J. Levine suggested educating community paint stores on heritage colours.
