Permit Application Requirements

A sprinkler permit is required for the installation, alteration or connection of a fire sprinkler system.

Registered Professional to be retained for the design and field review of the following fire sprinkler systems:

- new installation
- renovation/alteration affecting 20 or more devices
- building addition floor area / mezzanine / floor levels
- change of building occupancy classification / hazard
- tenant improvement commercial kitchens / breweries / spray booths
- equipment requiring specialized suppression / separate acting systems
- where deemed necessary by the authority having jurisdiction
